## **VISTO:**

El Expediente N° 08030-0007084-2 del Sistema de Información de Expedientes, mediante el cual se gestiona la aprobación de diversas licencias y permisos gozados en los meses de SEPTIEMBRE y OCTUBRE de 2023 por agentes del Servicio Público Provincial de Defensa Penal (SPPDP), y;

## **CONSIDERANDO:**

Que la Ley N° 13.014 de la Provincia de Santa Fe creó el Servicio Público Provincial de Defensa Penal determinando en su artículo 9 que *“es un órgano con autonomía funcional y administrativa y con autarquía financiera, dentro del Poder Judicial”*.

Que en ese marco, y sin perjuicio de las tardanzas y/o inasistencias injustificadas que pudieran ocasionar descuentos sobre sueldos y sanciones disciplinarias (conforme al art. 9 Resolución 51/17 y modificatorias) y deben ser resueltas mediante acto administrativo particular, la Defensora Provincial encuentra conveniente conceder las diversas licencias y permisos solicitados oportunamente por el personal del organismo, dando por autorizados los motivos expuestos en las planillas anexas “A” y “B”, integrante de la presente resolución, conforme lo establecido en el Reglamento respectivo, aprobado por Resolución N° 51/2017 y modificatorias.

Que la presente se emite conforme a lo dispuesto en el artículo 21 de la Ley N° 13.014, especialmente en sus incisos 1), 5), 6) y último párrafo.
